This notice is to inform you that westbound SW Meinecke Parkway west of Highway 99 will be closed from 9:00AM to 7:00PM Monday October 26 to Wednesday October 28 for the construction of storm sewer facilities within westbound SW Meinecke Parkway. Beginning the closure at 9:00 AM will allow residents and school buses to travel uninhibited during the morning peak hour. Afternoon and evening peak traffic will need to use one of the detour routes on the attached drawing. Please note that the newly constructed SW Cedar Brook Way will be opened prior to the closing of westbound SW Meinecke Parkway. Closure of the work zone during the afternoon and evening peak traffic hours will allow the duration of the construction/road closure to be completed within a 3 day period.

Eastbound SW Meinecke Parkway in this area will remain open during these construction operations.



