INFRASTRUCTURE HIGHLIGHTS

WATER/UTILITIES

The City sources its water from the nearby Willamette River Water Treatment Plant and the existing supply and planned improvements will meet the future water needs for businesses in the city and its urban growth areas. The Sanitary System Master Plan was updated in 2016 and the improvements and expansions described in the Plan will allow the city to meet the needs of the identified employment areas.

FIBER

Sherwood has a robust fiber network. Sherwood Broadband is the community-owned broadband provider with over 100 miles of fiber. Sherwood Broadband provides high speed internet and private network services to businesses and residents located in the City of Sherwood.

FREEWAYS/HIGHWAYS

Businesses locating in Sherwood have ready access to Highway 99W which traverses the community and to I-5 which serves all West Coast markets. The city is also readily served by I-205 which connects Sherwood to the entire Greater Portland Region.
