III. Scope

The City is soliciting bids for materials to support the expansion of our broadband utility. The materials needed for the expansion is a multi-year duration project. It will be necessary for the bidders to plan for some storage capability as the City does not have room to receive all materials.

Included is a list of anticipated materials for our project. You will find 3 different tabs on the spreadsheet. Each spreadsheet is to be completed separately.

In addition is our Fiber Optic Network Design and Construction Specifications to aid in the completion of the material listing.

IV. Contract Pricing and Adjustments

As this is a multi-year duration project, it is the intent of the City to enter into an agreement with the lowest bidder. This agreement will be for one year, with the option to renew up to three (3) additional years for a total, not to exceed, four (4) years.

Prices shall be firm through the first year of the agreement, with the following exceptions:

- A. City shall be given immediate benefit of any price decreases.
- B. Bidder shall promptly notify the City of amount and effective date of any decreases.
- C. Any decrease shall apply to any item(s) requested on or after the effective date of decrease

Bidder may propose price adjustments in writing not less than 60 days prior to the anniversary date of the agreement. City shall have the option to either accept the price

increase effective on the anniversary date or terminate the contract. All bids for price increases shalt be accompanied by documents showing an increase in Bidder's cost for each item for which a price increase is proposed.

Each bid must contain a statement as to whether the bidder is a Resident Bidder as defined in ORS 279A.120.

The City of Sherwood reserves the right to reject any or all bids submitted, or to waive any minor formalities of this request if, in the judgment of the City Manager, the best interest of the City would be served (ORS 279B.100).
