SUBJECT: Resolution 2015-069, re-appointing Joe Turner as the City of

Sherwood Hearings Officer

Issue:

Should the Council authorize the City Manager to sign a contract with Joe Turner as a Hearings Officer for a period of three years?

Background:

The Hearings Officer is appointed by the City Council for a term of three years. The Hearings Officer serves as the Hearing Authority for conditional use permits, subdivisions less than 50 lots, site plan reviews for projects between 15,001-40,000 square feet of floor, parking or seating capacity area. If there is not a Hearings Officer, the Planning Commission is expected to perform those duties. The Hearings Officer conducted two hearings in 2013, four in 2014 and no hearings to date in 2015.

Financial Impacts:

The application fees are expected to cover the costs and are considered in the department's professional services budget within the adopted budget.

Recommendation:

Staff respectfully recommends City Council adoption of Resolution 2015-069, reappointing Joe Turner as the City of Sherwood Hearings Officer.



RESOLUTION 2015-069

RE-APPOINTING JOE TURNER AS THE CITY OF SHERWOOD HEARINGS OFFICER

WHEREAS, the Sherwood Zoning and Community Development Code provides for certain types of land use applications to be heard by a Hearings Officer; and

WHEREAS, contracting Rules for Personal Service Contracts of less than \$100,000 authorizes a direct appointment; however, the City chose to solicit qualifications from multiple candidates to ensure the quality of services and responsible costs; and

WHEREAS, the City solicited potential candidates for Hearings Officer from two qualified candidates, including the current Hearing Officer, Joe Turner, and reviewed their qualifications and fees, and

WHEREAS, after reviewing the qualifications and fees, the Planning Manager and City Manager have recommended Joe Turner be re-appointed as Hearings Officer; and

NOW, THEREFORE, THE CITY OF SHERWOOD RESOLVES AS FOLLOWS:

Section 1:	The City Council accepts the City Manager's recommendation to re-appoint Joe Turne
	as Hearings Officer.

- <u>Section 2:</u> The City Manager is hereby authorized to execute a professional services agreement with Joe Turner to serve as Hearings Officer with a term expiring August 31, 2018.
- **Section 3:** This Resolution shall be effective upon its approval and adoption.
