

## **RESOLUTION 2009-069**

A RESOLUTION SUPPORTING THE ANNEXATION OF THE URBAN GROWTH BOUNDARY (UGB) AREA ASSOCIATED WITH THE PORTLAND GENERAL ELECTRIC (PGE) ANNEXATION INTO THE CLEAN WATER SERVICES (CWS) DISTRICT BOUNDARIES

**WHEREAS**, the landowner (Portland General Electric) initiated the annexation of the 34.2 acre UGB Area into city limits in May 2009 by petition under ORS 222.111; and

**WHEREAS**, the City approved placing the annexation vote on the ballot via Resolution 2009-064 and certified the explanatory statement to be included in the November 2009 voters pamphlet via Resolution 2009-066; and

WHEREAS, annexation into the City of Sherwood boundaries by public vote does not simultaneously result in annexation into the Clean Water Services district boundaries; and

**WHEREAS**, in order to receive public sewer through the City and/or Clean Water Services, the area must be within the Clean Water Services District; and

WHEREAS, Clean Water Services is considering annexation and has requested a resolution of support from the City of Sherwood; and

**WHEREAS**, it is in the best interest of the City of Sherwood and the orderly and efficient development of this area, that the area be annexed into the Clean Water Services District.

## NOW, THEREFORE, THE CITY OF SHERWOOD RESOLVES AS FOLLOWS:

<u>Section 1:</u> The City of Sherwood recommends that the 34.2 acre UGB area associated with the Portland General Electric (PGE) annexation, identified in the aforementioned resolutions and Exhibit A & B (attached), be annexed into the Clean Water Services district boundaries to allow orderly and efficient development of this area.

<u>Section 2:</u> This Resolution shall take effect immediately upon its passage by the Council and signature by the Mayor.

Thence S01°19'34"W, along the west line of said Plat of "Sherwood Commercial Center", 760.65 feet to the northeast corner of Parcel 2 of Partition Plat 1999-085, Washington County Plat Records;

Thence N88°29'47"W, along the north line of Parcel 2 of said Partition Plat 1999-085, 660.81 feet to the northwest corner thereof also being a point on the east line of that Statutory Bargain and Sale Deed recorded as Document Number 2005-063362, Washington County Deed Records;

Thence N01°21'17"E, along the east line of said Document Number 2005-063362, 107.77 feet to the northeast corner thereof:

Thence N88°33'54"W, along the north line of said Document Number 2005-063362, 432.93 feet the most easterly northeast corner of Parcel 2 of Partition Plat 1994-013, Washington County Plat Records;

Thence N50°36'13"W, along the northerly line of Parcel 2 of said Partition Plat 1994-013, 438.74 feet the southeast corner of Parcel 2 of said Partition Plat 2003-025;

Thence N39°27'48"E, along the east line of Parcel 2 of said Partition Plat 2003-025, 1,235.58 feet to the northeast corner thereof also being a point on the south line of Tract A of said Partition Plat 2001-048;

Thence S88°27'45"E, along the south line of Tract A of said Partition Plat 2001-048, 15.92 feet to the southeast corner thereof;
