

RESOLUTION 2020-034

AUTHORIZING THE CITY MANAGER TO SIGN A ONE YEAR EXTENSION OF THE CURRENT INTERGOVENMENTAL AGREEMENT WITH METRO FOR THE SOLID WASTE COMMUNITY ENHANCEMENT PROGRAM

WHEREAS, the Metro Solid Waste Code is set forth in Title V of the Metro Code; and

WHEREAS, Metro Solid Waste Code Chapter 5.06 contains the requirements for the Community Enhancement Program; and

WHEREAS, the City of Sherwood has a facility that participates in the Metro Community Enhancement Program; and

WHEREAS, through Resolution 2015-047 the City of Sherwood has a current IGA with Metro, and

WHEREAS, the term of the original IGA was for five years and is set to expire on June 30, 2020, and

WHEREAS, Metro has proposed an amendment to extend the current IGA for a one-year period.

NOW, THEREFORE, THE CITY OF SHERWOOD RESOLVES AS FOLLOWS:

- <u>Section 1.</u> The City Manager is hereby authorized to sign the amendment to the current Intergovernmental Agreement (IGA), attached as Exhibit A, with Metro for the Solid Waste Community Enhancement Program.
- Section 2. This Resolution shall be effective upon its approval and adoption.

AMENDMENT NO. 1 TO METRO INTERGOVERNMENTAL AGREEMENT NO. 933297

This First Amendment amends the Intergovernmental Agreement (Agreement) with City of Sherwood.

In exchange for the promises and other considerations set forth in the Agreement, the parties agree as follows:

A. <u>Purpose</u>

The purpose of Contract Amendment No. 1 is to revise (1) Section 2: Term to change the Agreement termination date to June 30, 2021.

B. Provisions of the First Amendment

Amendment of termination date, Section 2: Term

Section 2: Term of the Agreement is amended to extend the termination date from June 30, 2020 to June 30, 2021.

C. <u>No Other Modifications</u>

Except as modified herein, all other terms and conditions of the Agreement will remain in full force and effect. Any conflict between the provisions of this First Amendment, on the one hand, and the original Agreement, on the other hand, will be resolved by reference to and reliance upon this First Amendment.
