- 1. CALL TO ORDER: Mayor Mays called the meeting to order at 7:11 pm.
- 2. COUNCIL PRESENT: Mayor Keith Mays, Council President Tim Rosener, Councilors Kim Young, Sean Garland, Renee Brouse, and Russell Griffin. Councilor Doug Scott was absent.

MOTION: FROM COUNCILOR GRIFFIN TO ADOPT THE CONSENT AGENDA. SECONDED BY COUNCILOR YOUNG. MOTION PASSED 6:0, ALL PRESENT MEMBERS VOTED IN FAVOR (COUNCILOR SCOTT WAS ABSENT).

Mayor Mays addressed the next agenda item.

#### 6. CITIZEN COMMENTS:

No citizen comments had been submitted and Mayor Mays addressed the next agenda item.

#### 7. NEW BUSINESS:

#### A. Resolution 2021-037 Adopting the Capital Improvement Plan (CIP) for FY2021-22

Community Development Director Julia Hajduk explained that this resolution was a team effort between Community Development, Public Works, and Finance. She explained that the one-year CIP projects list were the projects that would be funded next year, pending budget approval. The five-year CIP list identified what city projects the city wanted to accomplish in the next five years. She stated that the proposed resolution included both the one-year CIP project list as well as the five-year CIP project list and included the projects that were incorporated into the city's various master plans. Mayor Mays stated that Council had reviewed the CIP multiple times every year. Mayor Mays asked for discussion or questions from Council on the proposed resolution. With no comments, the following motion was stated.

MOTION: FROM COUNCILOR YOUNG TO ADOPT RESOLUTION 2021-037 ADOPTING THE CAPITAL IMPROVEMENT PLAN (CIP) FOR FY2021-22. SECONDED BY COUNCILOR GRIFFIN. MOTION PASSED 6:0, ALL PRESENT MEMBERS VOTED IN FAVOR (COUNCILOR SCOTT WAS ABSENT).

Mayor Mays addressed the next agenda item. The City Recorder read the public hearing statement for all five public hearings. The City Recorder reported that no public testimony had been received for any of the public hearing items.

#### 8. PUBLIC HEARINGS:

## A. Resolution 2021-039 Adopting hiring standards, criteria, and policy directives for the City Manager position

City Attorney Josh Soper recapped that the city was currently in the process of recruiting a new city manager, and under Oregon law, in order to be able to conduct parts of the recruitment process in executive sessions (e.g. interviewing candidates or discussing council preferences regarding candidates they had interviewed or received applications from), it was necessary for Council to first adopt hiring standards criteria and policy directives for the hiring process. He explained that the standards criteria and policy directives were largely taken from the position profile that was developed by the City's recruiter and had already been advertised. He reported that there had been the addition of authorizing the City Manager

Pro Tem to be able to reimburse candidates for expenses for traveling to an interview. Mayor Mays asked for discussion or questions from Council. With no comments, the following motion was stated.

MOTION: FROM COUNCILOR BROUSE TO ADOPT RESOLUTION 2021-039 ADOPTING HIRING STANDARDS, CRITERIA, AND POLICY DIRECTIVES FOR THE CITY MANAGER POSITION. SECONDED BY COUNCIL PRESIDENT ROSENER. MOTION PASSED 6:0, ALL PRESENT MEMBERS VOTED IN FAVOR (COUNCILOR SCOTT WAS ABSENT).

## B. Resolution 2021-040 Adopting a Supplemental Budget for FY2020-21 and making appropriations

Finance Director David Bodway presented the "Supplemental Budget" PowerPoint presentation (see record, Exhibit A) and provided background on Oregon and local budget law. He stated that supplemental budgets were common and authorized by Oregon State Law to account for unforeseen financial needs or for new revenue sources. He explained that the city typically completed one mid-year adjustment and another adjustment near the end of the year. He reported that this year's adjustment amount was large enough to necessitate a public hearing. He reviewed the proposed changes to the General Fund. General Fund changes included accounting for the additional CARES money the City had received through Washington County, additional expenditures included an IGA with Washington County for the community Psyche grant program and city manager recruitment. He explained that two-thirds of the city manager recruitment expenditure would occur this fiscal year and the remaining recruitment expenditure was budgeted for the next fiscal year. He reported there were additional costs for software subscriptions, costs associated with remote work, and the creation of the new 2021 Sherwood URA. He reported that roughly \$1.1 million would go into the City's reserves for future years. The General Construction Fund included an additional \$1.4 million associated with the Cedar Creek Trail Project with funds coming from the Street Capital Fund to cover the costs. The Street Capital Fund had an additional \$110,000 transferred in from Street Operations. He explained that some of the capital projects moved more quickly than others, which required the City to use some of the reserve for future years for the projects. Council President Rosener asked if the negative \$2 million was the balance or the amount that was moved out of the fund? Mr. Bodway replied that typically in a budget there were revenues, expenditures, and reserves for future years amounts and explained that there was roughly \$5-6 million reserved for future years and the City was reducing that reserve for future years by that amount. He explained that the way Oregon budget law worked was that there were only certain funds that a city could budget for contingency and because this was a Capital Project Fund it did not allow the city to budget for any kind of contingency. He explained the City was allowed to remove that fund balance or reserve for future years. He stated an additional \$110,000 was transferred into the Street Operations Fund and that the Street Operations Fund had contingency and no reserves for future years were used. Mr. Bodway recapped the Storm Fund and explained that last year the City budgeted all of the capital projects under the Capital-side of the Storm Fund when in actuality some of the projects were a part of the Operations-side of the fund, but this year the projects were budgeted under their appropriate headings. For the Water Fund he explained that the city had completed a debt refinance transaction in February 2021 which would save the Water Fund roughly \$3 million over the remaining life of the loan. He explained that the City had to account for the first initial payment after the new debt refinance on June 1st and explained that the figure on page 6 of the presentation was the cost of principal and interest for that June 1st payment. Mayor Mays asked for discussion or questions from Council on the proposed resolution. With no comments, the following motion was stated.

MOTION: FROM COUNCILOR GRIFFIN TO ADOPT RESOLUTION 2021-040 ADOPTING A SUPPLEMENTAL BUDGET FOR FY2020-21 AND MAKING APPROPRIATIONS. SECONDED BY COUNCILOR BROUSE. MOTION PASSED 6:0, ALL PRESENT MEMBERS VOTED IN FAVOR (COUNCILOR SCOTT WAS ABSENT).

C. Resolution 2021-041 Adopting a Schedule of Fees as authorized by the city zoning and community development code, establishing fees for miscellaneous city services and establishing an effective date

Mayor Mays commented that he would ask that Council continue the hearing on the proposed resolution to Monday, June 21st after they received the report because of an adjustment Council needed to make on a short list of fees after Finance Director Bodway provided an overview. Finance Director David Bodway explained that each year during the budget process, Finance asked department supervisors to review the fees that they charge. He stated the proposed fees fell into four categories. He provided examples of some of the changes to the Fee Schedule such as a reduction for business license fees for new small businesses headquartered in Sherwood or manufacturing technology businesses. He reported that library fines and fees were removed. In planning and residential design there were additional fees added for residential design checklist. In the building section there was a fee increase for total valuation for single-family and two-family dwellings, manufactured dwelling installation permits, increases for the home setup and installation fees, and total valuation for commercial industrial and multi-family among others. He reported that the fees were included in the proposed FY21-22 budget and stated that there were no additional financial impacts of the proposed resolution. Councilor Young asked Mayor Mays why he wanted Council to wait to vote on this resolution? Mayor Mays explained that there was a short list of fees that were regulated by the charter, and since that charter change occurred, the annual inflation rate has exceeded that limitation, but the City had kept it to the 2% limit, and this year was the first year that it came in under that limit. He commented it was best to stick with the 2% to make up a little bit of what the City had lost or got behind on from prior years. Finance Director Bodway provided background and reported that in 2019 the CPI index was 2.8%, in 2018 and 2017 it was 3.1%. Councilor Garland asked if waiting to vote on the proposed resolution would have an impact on approving the budget at this meeting? Mayor Mays replied that delaying voting on this resolution would not impact voting on the proposed budget at this meeting as long as everything was accomplished by the end of June. The following motion was stated:

MOTION: FROM MAYOR MAYS TO CONTINUE THE PUBLIC HEARING ON RESOLUTION 2021-041 ADOPTING A SCHEDULE OF FEES AS AUTHORIZED BY THE CITY ZONING AND COMMUNITY DEVELOPMENT CODE, ESTABLISHING FEES FOR MISCELLANEOUS CITY SERVICES AND ESTABLISHING AN EFFECTIVE DATE, TO JUNE 21, 2021. SECONDED BY COUNCIL PRESIDENT ROSENER. MOTION PASSED 6:0, ALL PRESENT MEMBERS VOTED IN FAVOR (COUNCILOR SCOTT WAS ABSENT).

Mayor Mays closed the public hearing for Resolutions 2021-039 and 2021-040.

#### D. Resolution 2021-042 Declaring the City's Election to receive State Shared Revenues

Finance Director Bodway presented the "State Shared Revenue Public Hearing" PowerPoint presentation (see record, Exhibit B) and explained that the City was required to hold two public hearings for this resolution in order to obtain and receive State Shared Revenues per state-law. He stated that the first

hearing was held on May 27th during the final Budget Committee meeting. He explained that the State Shared Revenue Sherwood received was allocated based on Sherwood's population of 19,885 residents as of December 15, 2020. He reported that the revenue fell into the intergovernmental revenue of the General Fund and the intergovernmental revenues of the Street Operations Fund. He provided an overview of the various State Shared Revenue's on pages 3-5 of the presentation. He recapped what the State Shared Revenue funds could be used for on page 6. Councilor Young clarified that the State Shared Revenue of the marijuana funds was not restricted, only the local was restricted. Mr. Bodway replied that was correct. Mayor Mays closed the public hearing portion and asked for discussion or questions from Council. Councilor Garland asked if the amount the City received from the marijuana taxes in the first year was \$265,000? Mr. Bodway reported that he was required to combine the marijuana tax revenue with the other state Shared Revenues because there was a local operator. He explained that there was the local tax portion as well as the money the City was receiving through the state, so for the current fiscal year, Measure 110 was only supposed to affect the last quarter of this fiscal year and he was projecting in totality around \$65-70,000. He commented that the marijuana revenue would decrease significantly for the upcoming fiscal year due to Measure 110 and commented that the City was expecting roughly \$25-30,000. Councilor Garland asked if that would affect the local amount? Mr. Bodway replied that it did not affect the local amount, only the State Shared portion was capped at a specific amount. No comments from Council were received and the following motion was stated.

MOTION: FROM COUNCILOR GRIFFIN TO ADOPT RESOLUTION 2021-042 DECLARING THE CITY'S ELECTION TO RECEIVE STATE SHARED REVENUES. SECONDED BY COUNCILOR BROUSE. MOTION PASSED 6:0, ALL PRESENT MEMBERS VOTED IN FAVOR (COUNCILOR SCOTT WAS ABSENT).

E. Resolution 2021-043 Adopting the FY2021-22 budget of the City of Sherwood, making appropriations, imposing and categorizing taxes, and authorizing the City Manager to take such action necessary to carry out the adopted budget

Finance Director Bodway referred to the table on page 432 of the City Council meeting packet and explained that the final Budget Committee meeting was held on May 27th where they voted on the proposed budget. He reported that several changes had been made by the Budget Committee. The Budget Committee increased the intergovernmental revenue in the Sanitary Fund by \$1.95 million and explained that that figure was the reimbursement the City was receiving from Clean Water Services for the Rock Creek Trunk Project. He reported that in the General Fund, salaries were decreased because there were requests for positions for the library and the Budget Committee wished to see what the future of the intergovernmental agreement and library cooperative would look like, so the positions were removed from the budget. He reported there was language clean up in the Capital Improvement Plan. He explained that the budget was now ready to be voted on by the Council and formally adopted. He stated this was the final opportunity for citizens to provide public comment on the proposed budget and noted that no public comments had been submitted. Mr. Bodway thanked the Budget Committee and Finance staff for their hard work on the proposed budget. With no comments or questions, the following motion was stated.

MOTION: FROM COUNCIL PRESIDENT ROSENER TO ADOPT RESOLUTION 2021-043 ADOPTING THE FY2021-22 BUDGET OF THE CITY OF SHERWOOD, MAKING APPROPRIATIONS, IMPOSING AND CATEGORIZING TAXES, AND AUTHORIZING THE CITY MANAGER TO TAKE SUCH ACTION NECESSARY TO CARRY OUT THE ADOPTED BUDGET. SECONDED BY COUNCILOR GRIFFIN.

MOTION PASSED 5:1, MAYOR MAYS, COUNCIL PRESIDENT ROSENER, COUNCILORS GARLAND, YOUNG, AND GRIFFIN VOTED IN FAVOR. COUNCILOR BROUSE OPPOSED, (COUNCILOR SCOTT WAS ABSENT).

Mayor Mays gave his kudos to City staff and the Budget Committee for their work on putting the budget together during a pandemic.

Mayor Mays addressed the next agenda item.

#### 9. CITY MANAGER REPORT:

City Manager Pro Tem Kristen Switzer provided a status update on the city manager recruitment process and explained that the recruitment period closed on June 14<sup>th</sup> and reported that the recruiter had received 34 applications from 13 different states.

Councilor Griffin asked if the June 22<sup>nd</sup> meeting would be virtual or in-person? Mayor Mays replied that the meeting would be in-person. Councilor Brouse asked regarding the meeting start times for both upcoming meetings. City Manager Pro Tem Switzer replied both meetings would start at 6:00 pm.

Mayor Mays addressed the next agenda item.

#### 10. COUNCIL ANNOUNCEMENTS:

Councilor Garland commented regarding his children attending Archer Glen and gave his kudos and thanks to the teachers and administration at Archer Glen.

Councilor Brouse reported that both the Senior Center and the Library Advisory Board were continuing to open their facilities safely for their clients in order to serve the community. She encouraged people to visit the new Sherwood business "Meadowlark Mercantile."

Councilor Griffin reported on his attendance at the Parks and Recreation Advisory Board meeting where they discussed pickleball in Sherwood and announced that the Parks and Recreation Advisory Board had a vacancy.

Councilor Young reported on her attendance of the Washington County CDBG Policy Advisory Board meeting and explained in January they had allocated \$200,000 of CARES spending towards a shower trailer and announced they had opened the application process and received one application. She reported that the board was currently reviewing and scoring that application. She explained the applicant proposed to purchase two-based shower stalls which will move around the county for people to use who do not have access to shower facilities. She reported that the YMCA facility had fully reopened, with no mask requirements for fully vaccinated individuals. She recapped YMCA summer programs.

Council President Rosener attended the WRWC meeting where they heard project updates. He gave his kudos to Washington County for leading the state in percentage of people who are at least partially vaccinated. He encouraged residents to get their COVID vaccines.

Mayor Mays reported that Sherwood would host the board of the League of Oregon Cities on June 18<sup>th</sup> at the Arts Center. He reported that past president of the LOC, the Mayor of Maupin, Dennis Ross had passed away. He attended the WCCC meeting where they discussed a potential future MSTIP program and a review of the bylaws.

#### 11. ADJOURN:

Mayor Mays adjourned the regular session at 8:01 pm and convened an executive session.

He explained that every item highlighted in green in the agenda packet had since been increased to the recommended 2%. Mr. Bodway explained that these fees were reviewed yearly during the budget process in order to determine if there needed to be any fee increases to keep up with inflation. Councilor Griffin asked Mr. Bodway to explain what the different font colors meant in the document. Mr. Bodway explained that green meant that there was a rate increase from the prior year (2% CPI) as per Resolution 2017-008, purple meant that there had been a rate increase from the prior year rate (ENR 4.01%, CPI-W 2.4%) per Resolution 2018-049, blue meant that it had been changed from the prior year, and the yellow highlight meant "other." Councilor Young clarified that the CPI for this year was only 1.5%, but the City had the allowance where it could raise the CPI to 2% per a previous ballot measure that was now a part of the City Charter. Mr. Bodway replied that was correct and added that there had been years when the CPI was more than 2%, but the City did not charge more than 2%, which caused the City to fall behind, and this would allow the City to help recover from prior fiscal years. Mayor Mays closed the public hearing portion and asked for discussion or a motion.

#### **Background:**

Metro has imposed a construction excise tax on building permits since 2006. Funds from the tax are used for grants to local governments for comprehensive planning in the region.

The program initially was intended to sunset after \$6.3 million in taxes was collected. Metro subsequently changed this to a specified sunset date (first to September 30, 2014, then to December 31, 2020), and most recently, last year, Metro amended their code to eliminate the sunset provision entirely, making it a permanent program.

Metro has intergovernmental agreements (IGAs) with cities to collect the tax on their behalf and remit payments to Metro. These IGAs also have had sunset provisions that paralleled the above—initially based on a total dollar amount collected, then a specified date.

This Resolution would authorize the City Manager Pro Tem to execute an amendment to the City's IGA with Metro regarding collection of the construction excise tax to remove the expiration date clause and allow for continued collection. Obligations under the IGA would terminate upon either Metro's elimination of the construction excise tax program or 30 days after written notice to Metro from the City.

#### **Financial Impacts:**

The IGA permits the City to retain a 5% administrative fee for collecting the tax. In addition, the City is eligible to receive grants from the construction excise tax program.

#### Recommendation:

Staff respectfully recommends City Council approval of Resolution 2021-062, Authorizing the City Manager Pro Tem to sign an amendment to the construction excise tax collection intergovernmental agreement.



## AUTHORIZING THE CITY MANAGER PRO TEM TO SIGN AN AMENDMENT TO THE CONSTRUCTION EXCISE TAX COLLECTION INTERGOVERNMENTAL AGREEMENT

#### AMENDMENT TO CET COLLECTION IGA METRO / City of Sherwood

This Amendment to the Metro – City of Sherwood Construction Excise Tax Intergovernmental Agreement to Collect and Remit Tax ("Amendment"), is effective as of December 31, 2020, by and between Metro, a metropolitan service district organized under the laws of the state of Oregon, located at 600 Northeast Grand Avenue, Portland, OR, 97232 ("Metro"), and the City of Sherwood, located at 22560 SW Pine Street, Sherwood, Oregon 97140 (the "City"), collectively referred to as the "Parties."

WHEREAS, on August 8, 2006, Metro and the City entered into a Construction Excise Tax Intergovernmental Agreement to Collect and Remit Tax (the "CET Collection IGA"), which provided that the City would collect and remit Construction Excise Taxes pursuant to Metro Ordinance No. 06-1115 and Metro Code Chapter 7.04; and

WHEREAS, the original sunset date for CET collection was tied to the original sunset date of the Metro CET, which was the date on which Metro certified that all collecting jurisdictions had remitted a total of \$6.3 million in revenue; and

WHEREAS, in 2009 the Metro Council extended the Construction Excise Tax via Ordinance No. 09-1220, with a new sunset date of September 30, 2014; and

WHEREAS, in 2014 the Metro Council extended the CET via Ordinance No. 14-1328, with a new sunset date of December 31, 2020; and

WHEREAS, on September 29, 2014, Metro and the City entered into an agreement amending the CET Collection IGA to reflect the new sunset date and provide that the City would continue collecting the CET through December 31, 2020; and

WHEREAS, in 2018 the Metro Council adopted Ordinance No. 18-1425, which removed the CET sunset provision from Metro Code Chapter 7.04, making the CET a permanent source of revenue; and

WHEREAS, the Parties wish to again amend the CET Collection IGA to delete the sunset provision in Section 10 and thereby authorize the City to continue collecting the CET beyond December 31, 2020;

#### NOW THEREFORE, the Parties agree as follows:

1. The Parties hereby amend Section 10 of the 2014 CET Collection IGA to **delete** the existing language in Section 10, which states:

"Sherwood shall cease collection of the Construction Excise Tax pursuant to this CET Collection IGA on December 31, 2020."

#### And insert:

"In the event the CET is repealed or otherwise terminated by Metro, this agreement is also terminated effective as of the date the CET is legally terminated.

The project consists of widening the existing SW Roy Rogers Road street section within city limits. The right-of-way in front of the city property in this area is wide enough for the new street improvements, however upon research of the city's property line, it was discovered that a small part in the northwest corner of the property jogs out creating a need to dedicate this small piece (119 square feet) of the city's property to Washington County for the new street improvements.

Also, as part of these proposed street widening improvements, the existing overhead utility lines will need to be relocated to a public utility easement (PUE) outside of the right-of-way. Research concluded that no PUE exists adjacent to the right-of-way line within the above noted city property. Therefore, an 8-foot wide PUE needs to be dedicated by the City of Sherwood to Washington County to provide for relocation of the existing franchise utilities (see Resolution Exhibits A, B and C – Washington County Donation Agreement and Dedication Deeds).

Staff requests the Sherwood City Council authorize the City Manager Pro Tem to enter into an agreement to dedicate right-of-way and public utility easements to Washington County for the construction of SW Roy Rogers Road.

#### **Financial Impacts:**

There are no financial impacts with approving this request.

**RECOMMENDATION:** Staff respectfully recommends that the Council approve Resolution 2021-063, Authorizing the City Manager Pro Tem to sign Right-Of-Way and Public Utility Easement Donation Agreement and Dedication Deeds to the benefit of Washington County for the Construction of the SW Roy Rogers Road Street Improvements.





SUBJECT: Ordinance 2021-007, Vacating City right-of-way located along the east side of SW

Park Row Avenue and south to SW Willamette Street (First Hearing)

#### Issue:

Should the City release the public's interest in a segment of street right-of-way located along the east side of SW Park Row Avenue south to SW Willamette Street?

#### Background:

This Ordinance is being submitted as a public request from Erik and Sarah Olson, property owners of 15845 SW Willamette Street (Tax Lot # 2S132B004400). In the petition attached to this staff report as (Exhibit C), the Olson's describe the existing conditions of their property, and what vacation of the Park Row right-of-way would do to enhance the livability of their lot, without detriment to adjacent properties or City infrastructure.

Vacation of this right-of-way will attach the vacated right-of-way area to the adjacent property (Tax Lot # 2S132B004400) abutting the existing right-of-way, in conformance with ORS 271.140. ORS Chapter 271 describes the criteria and processes for vacating public right-of-way, which includes public noticing of the proposed action, consent of affected property owners, and a public hearing to determine if the vacation is in the public interest.

Vacation of this right-of-way has been reviewed by and deemed acceptable by the City of Sherwood Public Works Department, as it does not impact any City underground infrastructure, nor will it increase street maintenance efforts or costs. In addition, City Planning, Engineering and Public Works staff have reviewed the potential need for retaining the right of way and found that there is no long-term need. Portions of this ROW have been previously vacated in past City Council legislative actions (Ordinances 1981-745 & 1981-749). Park Row is currently a stub street, and residential site development of property beyond the stub street precludes further extension of the street. The Park Row stub street will not provide for any future City transportation expansion or connectivity needs. The City's Transportation System Master Plan also does not indicate any future extension of the existing Park Row right-of-way.

Vacation of this right-of-way will not have an adverse effect on any adjacent property values, whereas redevelopment of this land may actually increase the property value of adjacent properties.

City Council adoption of Ordinance 2021-007, vacating the Park Row right-of-way shown and described in the attached Exhibits "A" and "B", causes no negative impacts to City owned infrastructure. Vacation of the Park Row right-of-way will enhance Sherwood livability, and promote resident well-being.

A second hearing on this ordinance, if needed, has been scheduled for August 3, 2021.

#### **Financial Impacts:**

There are no future costs to the City associated with vacation of this right-of-way and the applicant has paid a deposit ensuring that the full cost of this request is paid for by them. Vacation of the right-of-way comprises the release of the public's interest in right-of-way that is no longer needed. Vacation of this right-of-way will add property in private ownership and thereby add to the taxable land base.

#### **Recommendation:**

City staff respectfully recommends that City Council conduct the first hearing and consider approval of Ordinance 2021-007, vacating City right-of-way located along the east side of SW Park Row Avenue south to SW Willamette Street.

  - The location and description of any existing easements recorded over or adjacent to the right of way.
- An exhibit of the survey with the extents of the vacation request shown as highlighted line work.
- A legal description of the requested right of way vacation area.
- Petition signatures from two-thirds (%) of property owners within 200 feet perpendicular, and 400 feet parallel to the property.

In addition to these materials, we have been thoughtful in our approach. We have met with both Bob, Joe, and other city personnel to ensure a smooth vacation process. Of the parties we have met, all have agreed that a vacation is both feasible and appropriate given our situation.

Last year, our family set out to fence the east side of our property to provide safety and privacy for our pets and two boys, ages ten and seven. In doing so, we discovered that the formal property line literally cut through the middle of our back yard. Though the property is visually perceived as part of our yard, and we have been maintaining it, the awkward property line was due to a 60 foot right-of-way for Park Row Avenue, which borders our property and is currently a "dead end" street.

In speaking with Bob and Joe, we found that the right-of-way was established in the event that one day Park Row Avenue was to connect to Washington Street. However, some time ago, because the city did not intend to construct a through-street, the land connecting Park Row Avenue and Washington Street was vacated to the property owners (Lots 9, 10 and 11). Because there is no planned through-street, and there are no public utilities in this area, we are requesting a partial vacation (see the proposed vacation map).

We would like to legally incorporate this area so we can continue improving the property by way of fencing, irrigation, and landscaping. Thank you for taking the time to review our proposal. Our goal is to continue to add value to our neighborhood, and to the City of Sherwood.

#### **ORDINANCE 2021-007**

## VACATING CITY RIGHT-OF-WAY LOCATED ALONG THE EAST SIDE OF SW PARK ROW AVENUE AND SOUTH TO SW WILLAMETTE STREET

**WHEREAS**, the City received a citizen sponsored petition to vacate City right-of-way, said right-of-way described in Deed Book 5, Page 20, recorded February 13, 1912, Washington County Deed Records, and located along the east side of SW Park Row Avenue up to SW Willamette Street, being more particularly described and shown on the attached Exhibit A (Survey Map) and Exhibit B (Legal Description); and

**WHEREAS**, the City posted notices of the vacation request and hearing at four public locations and at two locations on the vacation site, mailed notification to property owners within 500 feet of the vacation site, and published the notice in a local newspaper on two separate dates, June 17 and June 24, 2021, all in accordance with ORS 271.110 et seq.; and

**WHEREAS**, the petition for vacation included the written consent of the owners of all abutting property and of not less than two-thirds in area of the real property affected thereby, as defined in ORS 271.080; and

**WHEREAS,** title to the vacated right-of-way area will be attached to the adjacent property (2S132B004400) owned by Erik and Sarah Olsen per ORS 271.140; and

**WHEREAS**, the right-of-way sought to be vacated is not needed for any present or future purpose and the vacation of the right-of-way will not negatively impact any other adjacent property values; and

**WHEREAS**, the City Recorder has certified that the affected property is free of all City liens and no taxes are owed on the affected property; and


WHEREAS, a public hearing on this matter was held on July 20, 2021.
