REGULAR SESSION

1. **CALL TO ORDER:** Board Chair Scheirman called the meeting to order at 7:00pm
2. **BOARD PRESENT:** David Scheirman, Rodney Lyster, Jim Craig, Cory McLennan, Steve Munsterman, John Clifford, Joy Kuczer

STAFF PRESENT: Community Services Director Kristen Switzer, Operation Supervisor Harry Banister, and Volunteer Coordinator, Tammy Steffens.

3. **ADJUSTMENTS TO AGENDA:** None.
4. **APPROVAL OF FEBRUARY MEETING MINUTES:**
MOTION: FROM MUNSTERMAN TO APPROVE THE MARCH MEETING MINUTES.
SECONDED BY CRAIG. MOTION PASSES.

5. **CITIZEN COMMENTS:** None.

6. NEW BUSINESS

Murdock Park Master Plan (Switzer/Banister):

- Switzer stated that there were over 40 people in attendance at the Murdock Park Open House on March 21, 2024.
- Scheirman shared that he was very pleased with the attendance and that people were participating by using dot stickers to vote for what was important to them. He noticed that a bathroom and the vegetation seemed to be a priority.
- Munsterman was also impressed with the turnout. He noticed that several neighborhood residents were mis/uninformed, and the open house was a great opportunity to educate and inform people of the process.
- Banister noted that there seemed to be interest in more activities like bocci ball and 4-square. He stated that the two items that received the most votes were #1-a bathroom and #2-the observation deck.
- Kuczer shared that she had recently visited a park in another town that had a treehouse-style playground that her children had a lot of fun at.

Tree Removal (Harry Banister):

Banister reviewed Exhibits A with the Board. He also informed that Board that part of a tree had fallen in Pioneer Park and had damaged a fence on a neighboring property. It was declared an emergency to remove the tree for safety reasons.

MOTION: FROM CLIFFORD TO APPROVE REMOVAL OF THE RECOMMENDED TREES AT PIONEER PARK. SECONDED BY LYSTER. MOTION PASSES.

7. PARK MAINTENANCE REPORT (Banister)

- Restrooms at parks were opened on April 1 and outhouses delivered to Murdock and Pioneer Parks.
- Irrigation inspections are being conducted.
- Mowing has started in all parks.
- Sunshades in Robin Hood Plaza were put up on April 1. Switzer commented that by having the Public Works department put up the sunshades, it saved the City a lot of money.
- Water features will be turned on Memorial Day.

8. STAFF UPDATE (Switzer)

- Charter Review Committee meeting went well. They were able to go through the whole Charter. The committee asked for additional information on only a couple of sections. There will probably only be two more meetings. The committee will forward their recommendations to City Council by June/July so there is time to include proposed ballot measures for the November 2024 election (should the Council decide to move forward). Kuczer, who represents the Parks Board on the committee, shared that the 2% rate/fee increase limit was the only big topic.
- Mark your calendars for the Volunteer Appreciation Banquet on Thursday, April 25th.
- State of the City will be Wednesday, April 17, with a reception starting at 5pm and the program will begin at 6pm. All Board members are invited.
- CEP Grant applications are due April 15.
- City Manager Pro Tem sent an email out earlier in the day that included City Council's approved goals. Switzer encouraged the Board to review those. Scheirman requested that Switzer bring copies of the goals to the next meeting and highlight the goals that directly affected the Parks Board.
- There will be a joint meeting between City Council and the Sherwood School District on April 10. This normally occurs two times each year.
- All the bids for the fencing along Alexander Way for the Cedar Creek Trail project came back twice as much as expected so the project will be re-bid.
- The feeder trail by the senior center is getting ready to go out to bid. Kuczer ask about the trail expansion. Switzer anticipated that the City would start to ramp up for that portion of the project in approximately 1-2 years depending on funding. Munsterman suggested that historical signage around the feeder trail would be a nice feature, including the fact that at one time there was once a 9-hole golf course in that area.

- Craig commented on how well the pedestrian bridge groundbreaking went.

10. OTHER: Board member Brenda Kramer has moved out of town so is no longer eligible to serve on the Board. Clifford, Munsterman, and Rose are all coming up for reappointment.

Location: Green Space Behind 17074 SW Stellar Dr. Sherwood, OR.
Subject: Sweet cherry (*Prunus avium*)


Per your request, I inspected one sweet cherry (*Prunus avium*) located in the green space behind the address listed above to determine the tree's condition.

Description: One sweet cherry (*Prunus avium*). The tree's height is approximately forty-feet tall with a trunk diameter of eleven-inches as measured four and a half feet above ground level. The canopy spreads measure approximately twenty-feet in diameter.

Evaluation: The health and structure of the tree is rated poor as indicated by a ten foot section of the upper canopy that is completely dead. Old sap sucker wounds were found along the main stem, however the wounds have since compartmentalized. The tree is considered to be a nuisance species.

Results: Due to the tree defined as a nuisance species and the overall poor health and structure rating, I recommend the tree be removed.



Location: 17440 and 17452 SW Kinglet Dr., Sherwood, OR 97140
Subject: Cottonwood Trees

Per your request, I inspected twenty-three Black cottonwood trees (*Populus trichocarpa*) located within the green space in-between both addresses listed above to determine their condition.

Description/Evaluation: There are twenty Black cottonwood trees (*Populus trichocarpa*) trees with phototropic leans located in between both properties. The trees have an average Diameter at breast height of 18 inches as measured 54 inches above ground level. The trees are in fair health and exhibit poor structure.

There are three mature Black cottonwood trees (*Populus trichocarpa*) located at the south side of the grove that currently are in good health and exhibit fair structure. The trees have an average Diameter at breast height of 22 inches as measured 54 inches above ground level.

Results: Due to the tree's overall health and structure rating, the tree's close proximity to both residential dwelling and the safety of person/property, I recommend the twenty cottonwood trees to be removed. The three remaining cottonwood trees should be pruned for structure, removal of dead limbs and thinning through-out the upper canopy.


