REGULAR SESSION

1. **CALL TO ORDER:** Board Chair Scheirman called the meeting to order at 7:00pm
2. **BOARD PRESENT:** David Scheirman, Rodney Lyster, Jim Craig, Cory McLennan, Tara Khodadadian, Jim Booker, Barbara Leitzinger, Steve Munsterman

3. INTRODUCTION OF NEW MEMBERS

- Jim Booker has lived in Sherwood for just over one year. His background is in Natural Resources Economics with a focus on water.
- Barbara Leitzinger has lived in Sherwood since 2016. She is a Mental Health Therapist, active in sports, and has four children.
- Tara Khodadadian has lived in Sherwood for two years. She is a Behavior Analyst and Fitness/Yoga Instructor with two children.

7. NEW BUSINESS

1. **Murdock Park Master Plan Update** (Brett Hoornaert, Lango Hansen Landscape)

Hoornaert presented Exhibit A to the Board. Khodadadian asked about the gradient of the current trails and Hoornaert responded that the plan will address that so it will be 5% or less. Khodadadian asked about having a cover over some of the playground. McLennan agreed that would be a nice addition. Booker asked about the surface of the flexible space, pointing out that some activities can be loud on pavement. Scheirman asked the Board how they felt about a sports court. All members agreed that a sports court was not the best option for this park with Snyder being so close and another park going in across Murdock that would include a sports court. Scheirman asked about a combined shelter and bathroom structure. Booker wondered if a drinking fountain and bathroom might get in the way if there was an event taking place under the shelter. Hoornaert stated that the results of the survey showed that the public strongly preferred the shelter and bathroom be separate structures. Scheirman suggested not replacing the play structure yet since it is only 11 years old. McLennan brought up the idea of bike parking. She also suggested a second drinking fountain and strongly advocated for covered areas to provide shade. Craig stated that Lango Hansen had done a good job incorporating community preferences. Khodadadian shared the idea of containing the playground area. Lyster commented that having the bridge made out of stone would match the natural resources being used. He encouraged seating areas being made out of stone rather than concrete and suggested that a world map on the flexible space would be a nice addition. Leitzinger stated that the nature areas and playground were nice and suggested that a disc golf course might be nice to serve an older generation. Hoornaert stated that the park didn't have a space big enough to accommodate a traditional disc golf course. Booker felt that Lango Hansen had done a good job of separating the serene from the active areas. He was disappointed that so many of the cottonwoods were being removed and asked if other large trees could be used to replace those. He added that the part of the trail closest to the corner of SW Upper Roy St and SW Williams Ave was a little tight and could it be rounded out. McLennan asked how many of the picnic table would be traditional vs ADA. Hoornaert stated that they would use best practices. Scheirman wrapped up the discussion that the recommendation to City Council would be no sports court and that the Board is in full agreement with the direction that Lango Hansen is going.

2. Tree Removal Request (Banister):

Banister shared Exhibit B with the Board.

8. PARKS MAINTENANCE REPORT (Banister):

- Cannery Square fountain is waiting for a part coming from California. Public Works is working on getting it fixed in time for National Night Out on Tuesday, August 6.

- Crews have been working festival season. Robin Hood Festival was a success. Halloween and Tree Lighting are the only two left.
- National Night Out is tomorrow night.
- The last Music on the Green for the year is this week.
- Movies in the Park starts August 9.
- Some maintenance will be taking place on the skate park.
- The light poles in Old Town are being painted. There are 52 hanging flower baskets. Those will be rotated during the painting to keep them all watered and looking healthy.
- The railing along the Cedar Creek Trail has been repaired.
- Crews have been working hard on lawn maintenance in the parks and trying to water enough to keep grass green but not too wet so that kids can still play.

9. STAFF UPDATE (Switzer):

- Switzer informed the Board that the Winter Hawks have purchased the Sherwood Ice Arena. They've been great to work with and are planning to be active in the community.

10. COUNCIL LIAISON ANNOUNCEMENTS (Switzer on behalf of Scott):

- There was only one meeting in July so things have been quiet with City Council.
- National Night Out is tomorrow night, Tuesday, August 6. Everyone is invited to come and enjoy live music and free hotdogs.
- City Council is expected to approved Craig Sheldon's appointment as City Manager at the meeting tomorrow night.

11. OTHER: Munsterman shared that the City of Newberg is building nine pickleball courts in Jacquith Park. Scheirman stated that he had recently visited an all-inclusive park in Lincoln City and encouraged anyone visiting down that to stop by. McLennan stated that the improvements made in Cook Park were amazing and suggested that if any of the Board members have an opportunity, they should visit Oro Park.

GUIDING PRINCIPLES

Based on direction from the 2021 Parks and Recreation Master Plan, the following guiding principles have been established as a starting point for this study.

Provide Green Solutions:

Add more native vegetation around the stormwater pond, convert turf not being used for recreation to ecolawn or drought resilient plants, increase landscape complexity, and plant more shade trees.

Promote Health and Accessibility:

The park should be a place for people of all ages, abilities, and recreation interest.

Enhance the Play Experience:

Build upon the existing playground and incorporate additional amenities, such as nature play elements and climbing features. Consider the location of elements to create a playful space that inspires joy.

Improve and Expand Park Amenities:

The Plan for Murdock Park must provide recreation amenities consistent with design guidelines for neighborhood parks, such as a picnic shelter overlooking the pond, a restroom, a sport court, and an enhanced path network with additional connections, a longer loop, and embedded measured distances.

Elevated Park Design:

The design of Murdock Park should inspire delight and be enduring and meaningful to the residents of Sherwood. Opportunities to express Sherwood's identity by integrating cultural, historic, and place-based art and interpretation should be capitalized on.

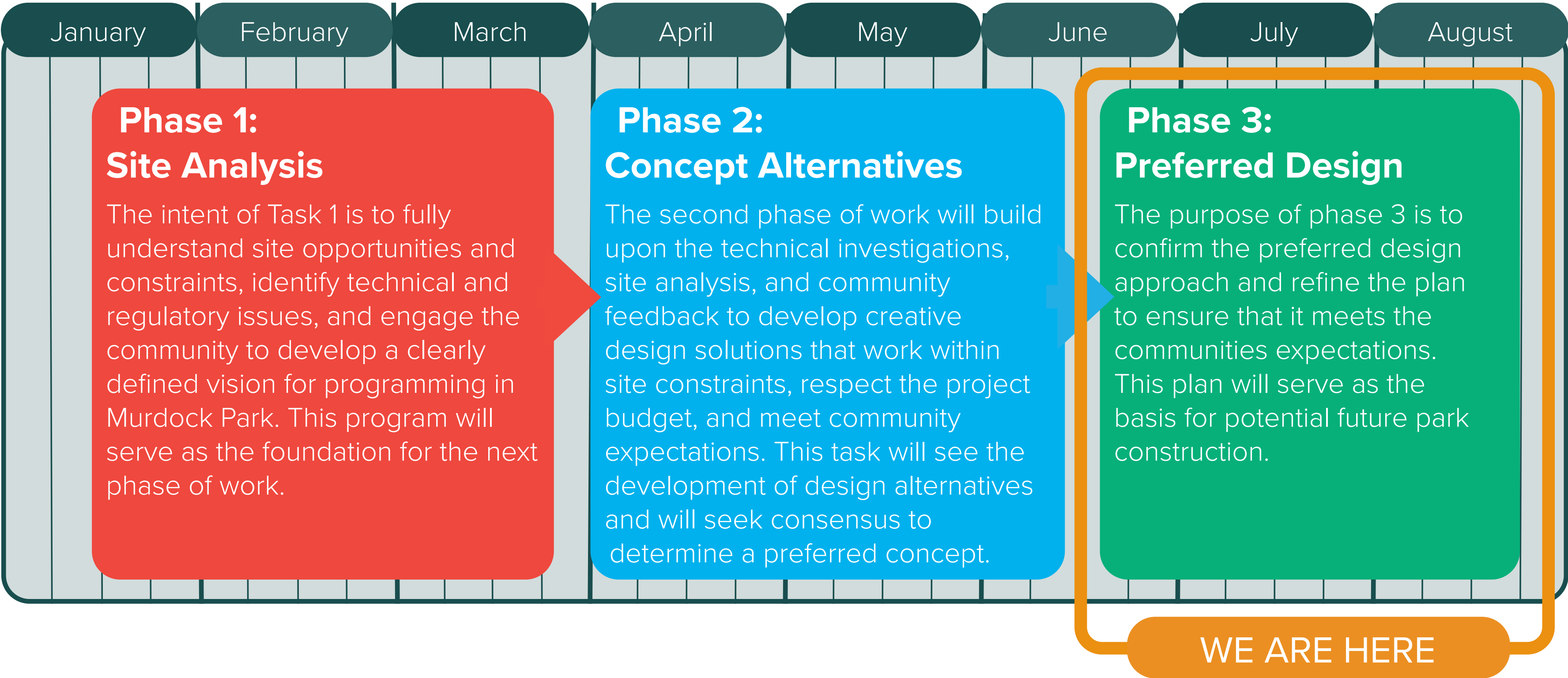
PROJECT BACKGROUND

Location: Green Space Behind 17169 SW Stellar Drive, Sherwood, OR.

Subject: Sweet cherry (*Prunus avium*)

Per your request, I inspected one sweet cherry tree (*Prunus avium*) located in the green space behind the address listed above to determine the tree's condition.

Description: One sweet cherry (*Prunus avium*). The tree height is approximately seventeen-feet tall with a trunk diameter of ten-inches as measured four and a half feet above ground level. The canopy spread measures approximately twenty-feet in diameter.

Evaluation: The health of the tree is rated fair with good bud development present. The structure of the tree is rated poor as the main stem is growing parallel to the ground with the crown growing towards the dwelling. The tree is considered to be a nuisance species.

Results: Due to the tree being a nuisance species and the overall poor structure rating, I recommend the tree be removed.

Reference: Tree Assessment

Location: Green Space Behind 17707 SW Elderview Dr., Sherwood, OR.

Subject: Black pine trees (*Pinus nigra*)

Evaluation: Tree number one is completely dead with indication of turpentine beetle damage present along the main stem.

Tree number two has experienced approximately ninety percent lower canopy loss. There is indication of turpentine beetle damage and pitch moth damage present at the basal root flare and along the main stem.

Tree number three is in good health and has a good structure rating. Turpentine beetle presence is found along the basal root flare.


Tree number four is in good health and has a good structure rating with normal interior dead limbs present. No indication of pest or fungal issues were found during the time of inspection.

Results: Due to tree number one and two's overall poor structure rating and for safety of persons and property, I recommend the trees be removed. Although tree number three is in good health, I recommend the tree to be removed as it will decline due to pest damage. Tree number four should be preserved and pruned to remove dead limbs would be recommended.

Location: Green Space Behind 17932 SW Handley Street, Sherwood, OR.
Subject: Black Cottonwood trees (*Populus trichocarpa*)

Per your request, I inspected two Black Cottonwood trees (*Populus trichocarpa*) located in the green space behind the address listed above to determine their condition.

Description: Tree number one Black Cottonwood (*Populus trichocarpa*). The tree height is approximately sixty-feet tall with a trunk diameter of twenty-inches as measured four and a half feet above ground level. The canopy spread measures approximately twenty-feet in diameter.

Tree number two Black Cottonwood (*Populus trichocarpa*). The tree height is approximately thirty-feet tall with a trunk diameter of twelve-inches as measured four and a half feet above ground level. The canopy spread measures approximately fifteen-feet in diameter.

Evaluation: The health and structure of tree number one is rated good with good bud development and normal interior dead limbs present. The health and structure of tree number two is rated poor as the tree has a phototropic lean that has not self-corrected with heavily weighted limbs growing towards the residential dwelling.

Results: Tree number one is recommended to be pruned for structure, removal of dead limbs and provide clearance from surrounding plant life. Due to tree number two's overall poor structure rating and for safety of persons and property, I recommend the tree be removed.

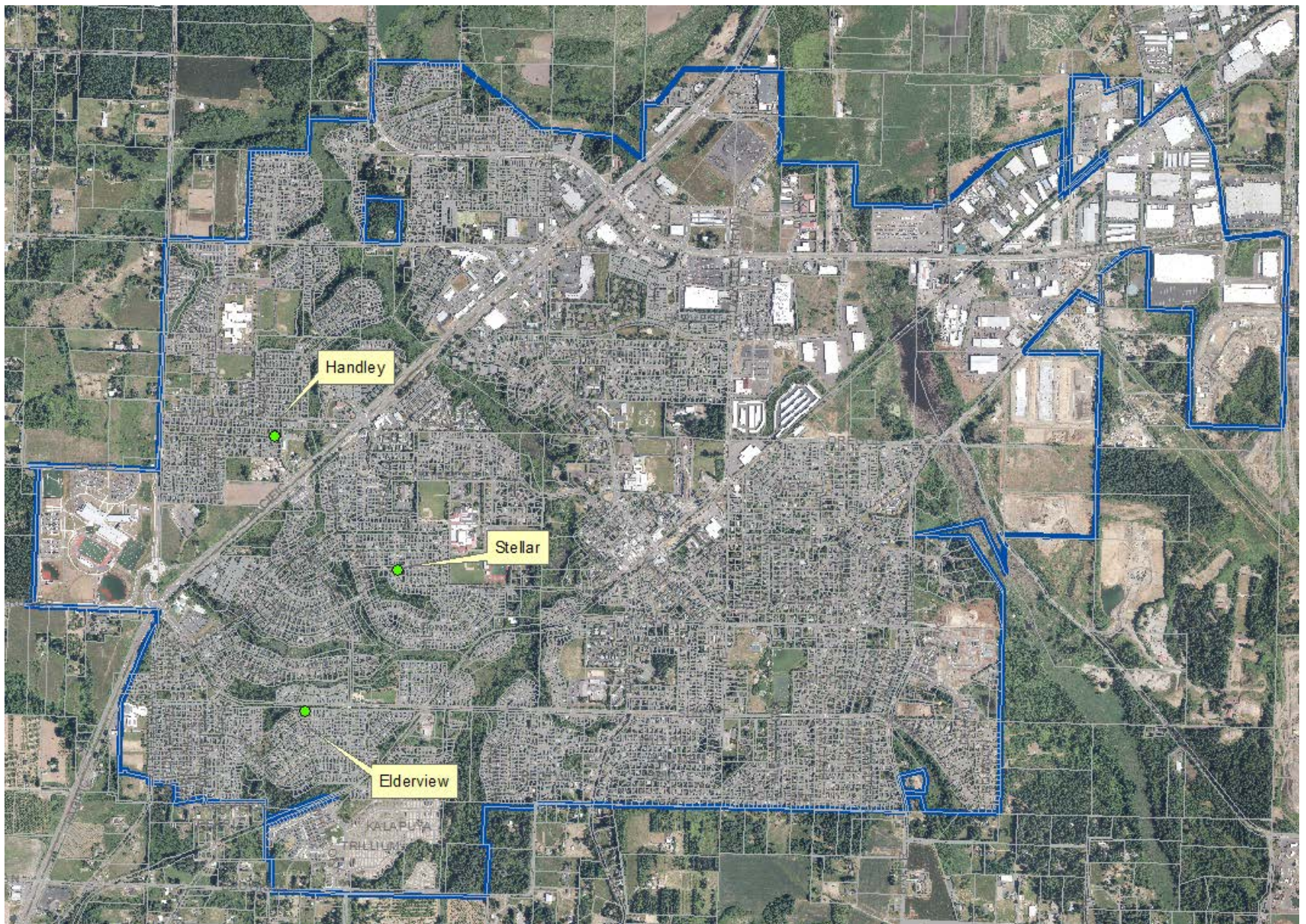
